Mobile Crisis 2023-2024 Grant – Potential Funding Solution: Bethany

As of now DHS has not been able to provide a guarantee of funding if they do not approve contracts by December 31, 2022.

AMHI 2023-2024 Grant – Potential Funding Solutions: Bethany

Bethany shared the five funding options that the Ex-Officios recommend in case the DHS contract does not get signed by December 31, 2022. There was some discussion whether to notify providers that funding may not be available.

Julie E. made a motion to send a letter of concern to Commissioner Harpstead indicating we have been experiencing significant contract issues with DHS; Tony seconded. All in favor, motion carried.

CAMHI will mail contracts to our providers. Should DHS not execute their contract by January 1, 2023, we will notify providers that funding may be cut.

In the event DHS does not sign the contract by December 31, 2022, we will fund providers until January 5, 2023 (the date of the next Joint Powers meeting).

Should DHS not have contracts signed by January 1, 2023, CAMHI will fund the AMHI and mobile crisis. If DHS is not willing to go back to provide funding for any services rendered as of January 1 and we will revisit at the January 5, 2023, Joint Powers meeting.

Attorney Recommendation: Bethany

The attorney advised we send out contracts out asking providers not to sign yet and remove the start date. Include a cover letter that explains the situation and the delay with the State. The entire contract is contingent upon our contract being fully executed and signed by DHS. Once DHS has signed our contract, instruct the providers to sign the, and fill in the date.

Based on our conversation, we will list the contract start date as January 1, 2023.

Sandi made a motion for Bethany to proceed with sending out the provider contracts; Tony seconded. All in favor, motion carried.

DHS Overpayment: Peggy
