Financial Report: Bethany

Grants are at 43% for end of September, which is 67% of the year. There was discussion on flex funds which are still available. Lori Long made a motion to approve the financial report. Diane Erkens seconded the motion and the motion carried.

RFP Update: Bethany

Three RFPs were sent out in August. Goodwill Easter Seals and Functional Industries will continue to be providers. Wellness in the Woods will be added as a provider starting January 2018.

<u>At Large Joint Powers Board Member</u> – Bethany

The Joint Powers Board has chosen Tracy Hinz is the new At Large Board Member.

Beautiful Mind Project - Mark Van Herr

This non-profit organization was established 3 years ago. A fund-raising effort is underway to raise \$125,000 for the addition of urgent care services to handle crisis mental health issues. The

organization averages 25-30 appointments per week. The organization has a goal of seeing clients (both children and adults) within 48 hours. Currently there are two providers, Seal Dwyer Counseling and Cook Counseling, both located in St. Cloud. The future plan to is to expand services to all four counties. The reimbursement rate and number of clients seen is determined by the providers. Insurance is accepted but is not required for service.

Wellness in the Woods: Todd Kuikka

Consumer Advocates: Bethany

CommUNITY Mental Health Initiative Committee and Grant: Updates

- a. Housing Coordination –. Meg summarized the Housing Coordination Report for August and September. (See handout for details.)
- Vocational Grant Krissy summarized the four-county vocational grant report for third quarter. The report reflects Functional Industries and Goodwill combined. (See handout for details.)
- c. Anti-Stigma Workgroup Bethany summarized upcoming events, including Take Back the Night, NAMI, and Project Connect. The workgroup meets the last Wednesday of each month.
- d. Training Workgroup –Bethany summarized upcoming training topics which include schizophrenia and grief and loss during the holiday season. Training session turnout has been good.
- e. Peer Mentoring Meg summarized the program transition from HOPE to Wellness in the Woods. (See handout for details.)

Community Based Mental Health Services: Updates

- a. IRTS Tracy reported 8 beds were occupied.
- b. ACT Tracy reported that a new team leader has been selected and other positions have been posted for the new ACT team. Services will start in December 1. The St. Cloud team had 69 clients and the Monticello team had 81 clients during the month of August.
- c. Crisis Response Team: Average 2.61 clients per day.
- d. Crisis Bed Program: Had a 52.25% occupancy rate.
- e. Inpatient:
 - i. St. Cloud Hospital: No updates.
 - ii. Buffalo Hospital: No updates.
 - iii. Monticello Hospital: No updates.
- f. V.A.: Mary Jo shared handouts on events and initiatives, as well as lists of contacts. There have been staff changes in several areas including the Homeless Program and a new Medical Chief of Staff. Some client services are being provided via video appointment from locations in other states. Some VA Hospitals are at full capacity, so the St. Cloud location is providing service to clients from outside the area.

VA events and services include: Stand Up event and a Stand Down event planned for this fall, Legal Advice Clinic, Recovery Night, Vocational Rehab Services, Suicide Risk Management Consultation (open to the public), National Disability Employment, Intimate Partner Violence Awareness Month, VA Health Care 101 including Veteran Services

- g. CBHH: James summarized the 2-day conference held for service providers. CBHH is making structural upgrades and remodeling plumbing to meet standards.
