Dear CAMHI Advisory Committee Members and Area Providers and Committees,

I am pleased to announce that the CommUNITY Adult Mental Health Initiative (CAMHI) will be offering mini-grants to area providers and/or committees. CAMHI will award up to \$140,000 to area providers and/or committees who will serve adult residents of Benton, Sherburne, Stearns or Wright County who have also been diagnosed with a serious and persistent mental illness.

In order to be considered as a recipient of a mini-grant, the provider or committee must fill out and submit the attached Mini-Grant Application. Submissions must be received by CAMHI no later than July 6, 2018. Applications may be faxed, emailed, mailed, or delivered in person. Applications received after the deadline will not be considered during the approval process. No exceptions.

Approvals and decisions for funding will take place mid-July 2018. All applicants will be notified shortly thereafter of the status of their application. Grant approval amounts may not necessarily match the dollar amount requested in the application. Finally, please note that a condition of this grant is that CAMHI must be billed for all costs by December 19, 2018.
