## Housing Coordination Services RFP: Bethany

Ex-officios would like approval from the Board to draft an RFP for Housing Coordination Services. They would like the Board's feedback on what they would like to see out of Housing Coordination Services.

We were awarded the Beyond Backgrounds Program, which has a Landlord Risk Mitigation fund that helps individuals who may have barriers such as a criminal record or poor rental history.

Julie offered to have the Stearns County Housing Coordinator, Summer Conard, come and share how she goes about finding housing for clients.

Bethany and Ex-Officios will work on updating the RFP and will have it at the next meeting for the Board to review.

## Medicare Letter: Bethany & Julie

The Stearns County Mental Health Task Force created a letter to send out to Representatives voicing concern regarding Medicare barriers for providers. The current credentialling under Medicare is extremely high. The letter asks Representatives to move forward the currently pending Bill, which will remove some of the barriers that Medicare has for mental health treatment. Currently, Medicare does not allow Licensed Professional Clinical Counselors (LPCCs), Licensed Marriage and Family Therapists (LMFTs) and Master's-level Psychologists (LPs). This has been introduced every year for the last 25 years but has still not passed.

Jami made a motion to have the Chair sign the letter; Bob seconded. All in favor, motion carried.

## **DHS Bonding RFP Update:** Dr. Lee

Met with the architect today, they are very close to finalizing the floor plan. It will have 9 crisis beds and 15 detox beds. They have had to cut some of common space from original plan but it will have a tele-medicine room. Currently on pace to break ground this spring. Dr. Lee will share the plans once they are finalized and the architect is ok with them being shared.
